In the reference 2<sup>nd</sup> cited, Manager (Recovery) and sub-Accountant (Development) section have been instructed to enquire whether the Bureau of Indian Standards is must for Gold Purity Testing Machine and the Central Excise Tax for Gold Purity Testing Machine and they have visited the o/o. Bureau of Indian Standards, CIT Campus, Taramani, Chennai and contacted Thiru.Jeevanandham, Joint Director Bureau of Indian Standards. He has informed that there is no Bureau of Indian Standards certificate issued for Gold Purity Testing Machine and also visited the o/o. The commissioner of GST and Central Excise Tax, Nandanam, Chennai-35 and contacted to Tmt. Akila, Superintendent she has informed that No charge for Central Excise tax to imported items and also removed the Excise Tax for the indirect Taxes, now charged GST only.

In the Terms and conditions of Tender Document it is mentioned in No.11(a), the manufacturer should specify the brand/make of Materials used confirming to the BIS Standards. Since it has been ascertained that there is no Bureau of Indian Standards certificate issued for Gold Purity Testing Machine and it is not mandatory to specify the brand/make of Materials used confirming to the BIS Standards, we request the Manager(CBS) to remove/modify the above condition accordingly in the Tender document and upload the same in TAICO Bank Website.
